Photographs must be on photo quality paper and not larger than 4x6 inches (10.2 cm x 15.2 cm). The ApHC reserves the right, at its discretion, to require additional photographs of better quality. Pictures become the property of the Appaloosa Horse Club. (If your Appaloosa's description has changed, the ApHC will describe your horse as it appears in the new photographs submitted.)

## How To Obtain a Duplicate Certificate Of Registration

After completing the Affidavit for Duplicate Certificate, forward it to the ApHC along with the \$20 fee (U.S. funds). Include with the Affidavit, four current colored photographs including both sides, a direct face and a rear view, clearly showing all face and leg markings, as well as close-up photographs of any brands and/or scars. Photographs must be on photo quality paper and not larger than 4x6 inches (10.2 cm x 15.2 cm). The ApHC reserves the right, at its discretion, to require additional photographs of better quality. Pictures become the property of the Appaloosa Horse Club. (If your Appaloosa's description has changed, the ApHC will describe your horse as it appears in the new photographs submitted)

## The following guidelines and interpretations may assist you in completing the affidavit.

1. When the Certificate was lost or destroyed by the Record Owner:

- The ApHC requires a proper affidavit from the Record Owner, notarized and stating the circumstances under which the Certificate was lost or destroyed as well as the proper fees and photographs.

  2. When the Actual Owner lost or destroyed the Certificate: The ApHC requires proper affidavits: one from the last recorded owner, that state the identity of the person to whom the horse was sold, and one from the actual owner, which states the circumstances under which the Certificate was lost or destroyed. Affidavits must be accompanied by a properly completed transfer or Bill of Sale (with proper fees).
- 3. When a Trainer or Race Official lost the Certificate: The ApHC requires proper affidavits: one from the Record Owner stating the identity of the person to whom he delivered the Certificate, and one from the person who had possession of the Certificate when it was lost or destroyed, stating the conditions under which it was lost or destroyed.
- 4. When the Certificate was lost or destroyed by neither the Record Owner nor the Actual Owner. In cases where a person(s) has possession of a horse but purchased it without the Certificate, the ApHC will not issue a Duplicate Certificate unless the following requirements are met:

  a. A properly completed, notarized affidavit from the **Record Owner** stating the identity of the person to whom he sold the horse and that he sold it **with** the Certificate of Registration,

  - b. A properly completed, notarized affidavit from the person who purchased the horse from the Record Owner, stating the circumstances under which the Certificate was lost or destroyed. If the horse has traded hands several times without official transfers being recorded with the ApHC, subsequent affidavits and transfer reports may be required.
  - c. Fees for each transfer for all above mentioned sales, and
  - d. A properly completed, notarized affidavit and proper fees from the Actual Owner stating that he was never in possession of the certificate.
- 5. When the Actual Owner is unable to locate the Record Owner to complete an affidavit: In these cases, the ApHC requires the following:
  - a. Proper affidavits signed by each party who had the Certificate in their possession after the Record Owner, b. Properly completed Transfers or original Bills of Sale showing each ownership beginning with the Record Owner,
