Agenda Items eligible for Membership & Board of Directors Consideration:

- Modify SHW804 to allow select all-around awards to count toward earning a superior allaround. **
 - (Amateur recommendation to Shows as primary)
- 7. Modify SHW240.3, Amateur and Youth Showing Leases, to allow during a lease period, the recorded owner to also show the horse as well as the recorded owner's immediate family in addition to the lessee and the lessee's immediate family. **

 (Amateur & Youth recommendations to Shows as primary)
- 8. Modify SHW240.3, Amateur and Youth Showing Leases, to allow during a lease period in International countries, the recorded owner to also show the horse as well as the recorded owner's immediate family in addition to the lessee and the lessee's immediate family. **
 - (Amateur & Youth recommendations to Shows as primary)
- 9. Modify SHW240.4, Amateur and Youth Showing Leases, to allow if a lease is terminated for any reason before the minimum one year, the recorded owner to show the horse as well as the recorded owner's immediate family in all divisions for which they are eligible, as well as by other eligible exhibitors in the Open Division, Level 1 and/or Rookie Classes. (Amateur & Youth recommendations to Shows as primary) **
- 10. Modify SHW245.3 Level 1 Eligibility, that any youth or amateur competing on an NCAA Equestrian Team on a scholarship or riding as a starting exhibitor should not be eligible for Level 1 in the classes for which they compete.

 (Amateur recommendation to Shows as primary)
- 11. Modify SHW245.3 Level 1 Eligibility, that no person who has appeared on the roster of a collegiate equestrian team, stock horse team or rodeo team shall be eligible for Level 1 Youth and Level 1 Amateur competition.
 - (Amateur recommendation to Shows as primary)
- 12. Modify SHW251 Level Eligibility, that no person who has appeared on the roster of a collegiate equestrian team, stock horse team or rodeo team and who has ridden in a

collegiate competition during his/her collegiate career shall be eligible for Level 2 Youth and Level 2 Amateur competition.

(Amateur recommendation to Shows as primary)

- 13. Modify SHW245.1 Level Eligibility, to include a person shall no longer be eligible for Level 1 competition in a specific class once that exhibitor has earned a total of 25 Level 1 points in said class or a cumulative total of 15 amateur, youth and open points in said class. (Amateur recommendation to Shows as primary) **
- 14. Request to allow participants competing at the Adequan Select World Show to be eligible for the Select All-Around Amateur Award, provided they meet the requirements for tabulation, regardless of their method of qualifying. Currently only national point qualifiers are eligible. **

- 15. Modify SHW245.3.1 and SHW245.3.2, to allow individuals who earned superiors or top three world show titles in the 1980s and 1990s but left showing and have returned, eligibility for Level 1 competition. **
